

4a (Code:) (Expenses \$ 971,124 including grants of \$) (Revenue \$ 234,496) The Field Program ensures the continued viability of the Long Trail and was successful at maintaining the trails, shelters and structures that are a part of the Long Trail system. The Field Program also engaged and educated users of the trails and worked to protect natural resources and the rare and endangered plants of Vermont's alpine zone. The Field Program continues to blend the efforts of hundreds of volunteers and a small dedicated staff to cooperate with agency partners and Vermont's business community to provide a world-class hiking resource for public use by all who visit the Green Mountains.

4b (Code:) (Expenses \$ 115,902 including grants of \$) (Revenue \$ 121,614) As a member-supported organization, the Green Mountain Club relies on annual dues from its 10,500+ members to continue its role in maintaining and protecting the Long Trail and other trail lands in Vermont. In FY13, the Membership program supported new member recruitment efforts via direct mailings to nonmembers, interactions with the public at community events, phone-a-thons, and local advertising; and recruited 1,604 new members. The program also works to keep existing members engaged through renewal mailings, information about volunteer opportunities and the club's fourteen geographically-based sections, and club-wide events like our Annual Meeting.

4c (Code:) (Expenses \$ 163,613 including grants of \$) (Revenue \$ 30,116) The Green Mountain Club Land Stewardship Program seeks to ensure that all lands acquired for the protection of the Long Trail and Appalachian Trail in Vermont are actively monitored and their property boundaries are maintained. Our 70 volunteer monitors oversee 35,000 acres of land and ensure that the boundaries are properly maintained and the lands are regularly visited to help deter encroachments and uphold the conservation values these lands were acquired for. In FY13, the GMC's Stewardship program reclaimed the boundary lines on three land tracts as well as responded to a variety of encroachments (such as ATV trespass) that were successfully mitigated.
